



# First Sentier Global Property Securities Fund

- The Fund invests primarily in equity securities or equity related securities issued by REITs or companies that own, develop or manage real property worldwide which may expose to risks similar to the direct ownership of real property and value of securities may fluctuate more than actual property. Operation and management of underlying properties and changes in economic conditions may impact its value. The Fund invests in emerging markets which may have increased risks than developed markets including liquidity risk, currency risk/control, political and economic uncertainties, high degree of volatility, settlement risk and custody risk.

- The Fund's investments may be concentrated in a single and limited/specialist sector, small numbers of companies or fast growing economies which may have higher volatility or greater loss of capital than more diversified portfolios. The Fund aims to achieve a total investment return consistent with income and long term capital growth. It invests primarily in a broad selection of equity securities or equity related securities issued by real estate investment trusts or companies that own, develop or manage real property from around the world (including initially the EEA, the UK, Russia, Switzerland, United States, and the Asian Region) and which are listed, traded or dealt in on regulated markets worldwide.

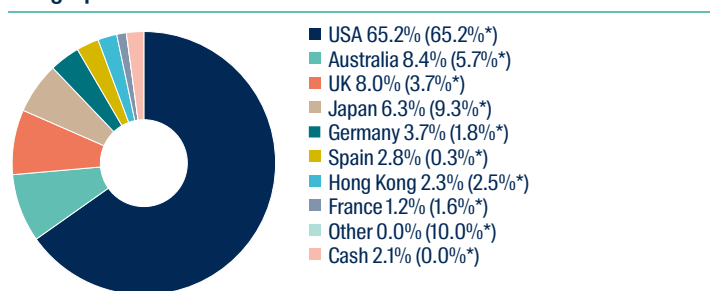

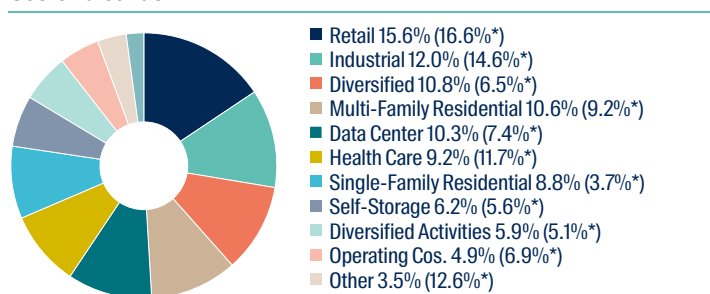
